4:05	Guest Speaker: Erin Bennett,	(Erin) With AHA, I am the Government Relations Director in Idaho (ID) and now Nevada. I work at the state and local
	American Heart Association	level on all kinds of things health related. Nicotine has immediate impacts on your system and brain. #1 focus is
		tobacco control and prevention. Our <u>Heart Powered Network</u> is a great place to see what we are working on and sign
		up to receive updates, as well as opportunities to get involved in advocacy. There is a wide portfolio we work on. One
		of the ways is connecting with volunteers and people. I recommend you look at the legislative website, sign up for bill
		tracker, and connect with legislators during the legislative session. There are easy ways to be an advocate, by doing a
		lot of education during conversations. This year we are focusing on raising tobacco taxes. ID has an exceptionally low
		tax rate that does not include e-cigarettes (vapes) or nicotine pods, and the tax rate has not been updated since 2003.
		Looking at retail licenses, we are lacking enforcement, making sure people are checking identification and not selling
		to minors. Idaho age for tobacco/nicotine products is 21. Make it a smoke-free state. I also serve as the President of
		the Tobacco Free Alliance in ID. Want all products to be treated in a similar manner and taxed accordingly. We know
		how tobacco/nicotine products affect the brain. The school board association has approved a resolution to bring a
		vape tax bill to legislative session. We have suggested language for them. Jan 12 th is the start date for leg session.
		Looking at Millenium Fund, these funds provide money for different areas of state government for tobacco control and
		cessation. Still not 100% supportive of what the Millenium Funds are doing. One of the challenges, they have given
		\$3M to the Department of Education for tobacco education and they are putting that into vape detectors which do not
		work. Rarely does a school have a response system to catch a student. (Katie R.) There is a parent group asking why
		West Ada (WASD) would not get vape detectors. Jeff Stands, explained why they don't work. Do you know of a
		factsheet stating why they don't work? (Erin) I have one and I will send it. What are interventions and prevention
		pieces that we can do that are cessation specifically towards children? Idaho got rid of ID Youth Risk Behavior Survey,
		we don't have any new data for youth behavior when it comes to nicotine. That is a challenge. Department of
		Education conducted a new survey that is trying to fill that gap, but it's not enough. Nicotine pods are now a favorite
		for high school students. The tobacco industries have created registries for e-cig/vapor registry for the state. We
		oppose it, it's coming from the industry, do you think it's actually for prevention? (Lacy) What agency is supposed to
		be enforcing tobacco? (Erin) Department of Health & Welfare Tobacco Project, two contract positions responsible for



enforcement and compliance checks. Been a little harder at the federal level. ID is still doing pretty good. Funneled the money through Department of Education and Health & Welfare. We've got a good solid group of people working on these things, there are challenges and we don't know what we are going to see from the CDC. As of now there is funding through June 2026 and then we don't know what will happen after that. We've got a lot of people on the fight and a lot of people willing to understand what the issue is. Most of us growing up, we got the message knowing smoking is bad. Nicotine pods are not like chewing tobacco, it's not the same. Experimenting on youth and we know the consequences. (Kendall) Who are you referring to when you say we? (Erin) Any organization or program where the millennium funding is going. (Kati C.) My position is included in this, Project Filter. (Erin) SROs. (Kendall) Is there a quick place to find the recipients for that funding? (Erin) No, it used to be easier to track but now it's about 12 different bills because of how other departments have changed how they work. (Kendall) Is Senator Grow still JFAC? (Erin) Yes. The resort city taxes and city authority. No other state has it. Not a big push for it recently, I have big dreams because what cities could do with that funding. (Anne) We pushed hard to get it; we ended up running a public safety levy because of that. (Erin) Happy to answer any questions. (Kati C.) One of the reasons for having Erin come is that she is so good at strategizing, knows how to word things, and when to put things on the back burner. For example, rural counties have issues with retail shops popping up close to schools. In small rural communities everyone knows everyone. A person reached out to me, and I thought I must get Erin involved. That person may have caused an issue with e-cig tax, and I knew we needed to be careful how we worded things. Erin is a great person to chat with. (Hailey) Can we include your email with the minutes? (Erin) Absolutely. (Kendall) Going back to state department of education and funding, is Idaho Office of Drug Policy (ODP) collaborating on programming? (Erin) There have been conversations, but I'm unsure how much overlap for projects. Questions regarding funding for ODP has put a barrier between everything. (Katie R.) I saw an AHA position post for a person to engage with the schools. If that person needs any contact with whom you hire, I'd love to work with them. (Erin) That is for our fundraisers for schools. It used to be called Jump Rope for Heart. Programming for K-12. All around heart health. Changed the program in the last couple years. (Katie R.) It looked like a great program. It had rewards for kids and fun characters. (Erin) Great program, but I don't know a ton about it. (Cheryl) With retail licenses, do they now include vape shops? (Erin) They do. Vape shops should have a license. The license costs nothing, it's just filling out a form. (Earl) Should it be displayed? (Erin) Yes, I don't know if it needs to be prominently displayed like alcohol licenses though. (Anne) There's a revenue opportunity. (Erin) We've been asking for that for the last 5 years. (Kati C.) Who funds the tobacco project? (Erin) Those are department funds, state police, and grant funds from a Central District Health grant, attached to federal grants. (Kati C.) The reason I ask is to have local law enforcement come together for tobacco compliance checks. Maybe there's room for those dollars going towards that? (Erin) Who is doing compliance checks and who is the authority? It's all a little fuzzy. There has not been a consistent person doing those compliance checks. (Lacy) With the licenses or any time they do retail sales, they must follow rules like alcohol. We know kids go through retailer garbage cans to look for expired vapes that have been thrown out. We want to require a lock-up but we don't do business licenses. (Erin)



		We've had several conversations regarding vapes disposals. There is not a great way to dispose of these products that
		isn't hazardous. That is one of the challenges and sources of pushback from retailers. (Lacy) They just go into the
		landfill now. (Erin) The batteries are explosive, and they leak toxins into the environment. 50 million products being
		thrown away. (Brenda) What are they doing to provide responsibility on the makers of these products? How is it that
		the producers can make things to put into their bodies but can't be disposed of? Do you know what some of the side-
		effects of it going into the soil? (Erin) Generally, the pods that go into the soil, all the different metals, chemicals, coils,
		etc. all go into the general environment. Products are bad for your body and bad for your environment. Third hand
		smoke – house that is dingy from a smoker, that is 3 rd hand smoke, Can still intake that years after. (Kati C .) And it's
		more carcinogenic. (Erin) It can be problematic that way. Responsibility with manufactures, a lot of these products
		come from places like China, they are not major retailers, most of them have passed through government protocols
		and were being sold as an alternative to smoking cigarettes. (Brenda) You can't make people from other countries pay
		for things being sold in US. (Erin) Recognize how this can lead to other drug use as well. (Kendall) If you have any
		other topics to discuss, please let us know. Residents of Meridian can drop off vapes at Household Hazardous Waste at
		Republic Services, not equipped for retailers. Vape disposal is part of the services offered at the DEA sponsored Rx
		take-backs each year. We have flyers available that have safe disposal information on them.
